

DFF Human-Machine Collaboration Licence ("DFF HMC Classification User Licence")

1. GRANT OF LICENCE

1.1 Dubai Future Foundation ("DFF") grants to the Eligible User ("you" or "your") a revocable, non-exclusive, non-assignable, non-transferable, non-sublicensable, limited license to use the DFF HMC Icons (in the form set out in Annex 1 of this Licence) ("Limited Licence") as a visual standard classification system, to show the extent to which research outputs have been shaped through the use of machines by you and/ or your team, in your research and publications ("Approved Use"). This Limited Licence supersedes any other agreement between you and DFF regarding the use of the DFF HMC Icons, with the exception of the Terms and Conditions (T&C's) which in the event of inconsistency shall prevail.

2. CONSIDERATION

2.1 The consideration for the grant of this Limited Licence shall be the promotional exposure to be provided to DFF by the Approved Use of the DFF HMC Icons.

3. DURATION

3.1This Limited Licence shall commence on the date of acceptance by you of this DFF HMC Classification User Licence ("Commencement Date") and shall expire on the earlier of (i) notification by DFF to you that the Limited Licence has expired or terminated; or (ii) completion of the Approved Use, unless terminated earlier due to you committing any breach of the terms of this Limited Licence and or T&Cs; or (iii) DFF bringing the DFF HMC Classification System to a permanent close.

4. OBLIGATIONS

- 4.1 You agree not to use or make reference in any manner to DFF that implies sponsorship or endorsement by DFF or any of its affiliates of you, or your works.
- 4.2 You represent and warrant that your (a) works for which you use the DFF HMC Icons in connection with will not violate any law or infringe upon the rights of any third party; (b) apart from the Approved Use, you will make no other use of the DFF HMC Icons; (c) this licence does not provide you with any right to make use of any other of DFF's Intellectual Property Rights in any way; and (d) you have the full power and authority to enter into this Limited Licence.
- 4.3 You acknowledge that all rights in the DFF HMC Icons and DFF HMC Classification System are the exclusive property of DFF, and all goodwill generated through your use of the DFF HMC Icons and DFF HMC Classification System will inure solely to the benefit and vest in DFF. You undertake not to take any action that is in conflict with DFF's rights in or ownership of the DFF HMC Icons and the DFF HMC Classification System.
- 4.4You agree that, unless otherwise expressly set out in writing by DFF to you, this Limited Licence does not confer any rights to use any of DFF's Intellectual Property Rights in any form. You agree not to register or use any mark, name, domain name, design, shape, word, designation, symbol or other trademark that includes, or are confusingly similar to, the DFF HMC Icons, or other intellectual property rights of DFF. If you become aware of any infringement, suspect infringement or alleged infringement relating to your use of the DFF HMC Icons, you agree to notify DFF in writing within 5 days after becoming aware of such information.
- 4.5 Unless otherwise instructed by DFF, You agree to include the following statement together with all use of the Museum: "All references to DFF and/or the DFF HMC Classification System and/or the DFF HMC Icons herein have been authorised and licenced by Dubai Future Foundation, including all intellectual property rights therein."
- 4.6 You recognise the goodwill attached to the DFF HMC Icons, all other intellectual property rights of DFF, its affiliates and the Government of Dubai and shall not knowingly or negligently take or do any action or permit or suffer any omission that would be detrimental to or adversely affect the goodwill associated with names of the DFF, its affiliates and/or the Government of Dubai or create unfavourable publicity or bring disrepute to Dubai, DFF, any of its affiliates or to the Government of Dubai at any time. You undertake to uphold the goodwill, reputation and image of Dubai, the Government of Dubai, DFF and its affiliates at all times.



5. INDEMNITY

5.1 You shall defend, indemnify and hold harmless DFF, its personnel, representatives and affiliates ("Indemnified Persons") from and against any and all claims, damages, liabilities, losses and expenses of any kind whatsoever (including the costs in connection with defending against any of the foregoing or in enforcing this indemnity) incurred or suffered by the Indemnified Persons arising out of or relating, directly or indirectly to, or in connection with, the Approved Use or any breach of this Limited Licence by you. The obligations set out in this Clause 5.1 shall survive any termination or expiration of this Limited Licence.

6. GOVERNING LAW AND DISPUTE RESOLUTION

This Limited Licence and the relationship between DFF and you shall be governed by the laws of Dubai and the federal laws of the UAE, and any dispute shall be referred to and finally resolved by the Dubai Courts.

7. GENERAL

- 7.1 You may not assign, subcontract, transfer, create a charge over or otherwise dispose of any of its rights or obligations under this Limited Licence without the prior written approval of DFF. Notwithstanding any approval from DFF to any assignment by you, you shall continue to be liable for all its obligations in this Limited Licence.
- 7.2 Nothing in this Limited Licence shall constitute or be deemed to constitute a relationship of an agency, partnership or joint venture between DFF and you.
- 7.3 No failure of any DFF or you to exercise, and no delay by it in exercising, any right, power or remedy in connection with this Limited Licence shall operate as a waiver of that right. A waiver of any right must be in writing.
- 7.4 DFF reserves the right, in its sole discretion, to change the terms of this Limited Licence and/or the DFF HMC Classification System, and/or the T&C's, or to cancel, suspend and/or modify the DFF HMC Classification System, the T&Cs and/or this Limited Licence at any time, including but not limited to, any of your rights and/or obligations.
- 7.5 If any term of this Limited Licence is or becomes illegal, invalid or unenforceable, that shall not affect the legality, validity or enforceability of any other term of this Limited Licence.
- 7.6This Limited Licence, together with the T&C's, contain the whole agreement between DFF and you relating to the Approved Use and supersedes all previous written or verbal agreements between DFF and you relating to the Approved Use.
- 7.7 Any expiry or termination of this Limited Licence shall not affect any accrued rights or liabilities of either DFF or you, nor shall it affect the coming into force or the continuance in force of any provision of this Limited Licence which is expressly or by implication intended to come into force or continue in force. Clauses 5, 6 and 7 shall remain in full force and effect notwithstanding any termination or expiry of this Limited Licence.
